This cost share agreement is between the agencies identified above, as negotiated for the following incident in accordance with the Montana Statewide Cooperative Fire Protection Agreement #L17FMA00001/17-FI-11015600-010 executed between the parties on (02/21/2017). The purpose of this agreement is to allocate financial responsibility as agreed upon and to describe the cost division.

Other conditions relative to this agreement:

1. Costs incurred by cooperators not engaged with the host agency or Incident Management Team (IMT) in the fire suppression activities will not be included as a part of this cost share agreement.
2. Responsibility for tort claim costs will not be a part of this agreement. Responsibility for these costs will be determined outside this agreement.
3. Agency specific costs will not be shared.
4. Costs for accountable, sensitive, and durable property purchased by each agency will be charged directly to that agency and will not be shared.
5. Non-suppression rehabilitation costs are the responsibility of the jurisdictional agency and will not be shared.



6. Each agency (including supporting agencies) will bill for their costs as outlined in the Montana Cooperative Fire Management Agreement billing procedures.

Protecting Agencies' Strategies:

Full suppression and perimeter control.

Cost Share Methodology and Rationale:

The cost share methodology chosen for this fire will be based on acres burned according to ownership and jurisdiction.

The DNRC is responsible for fire costs on State and Private lands. The BLM is responsible for fire costs on BLM owned land.

Both agencies have similar values at risk and agree on the same protection strategy.

The following is the breakdown of acres burned in the Judith River Road 2 Fire:

Private: 956.4 acres (Approximately 92%)
BLM: 76.8 acres (Approximately 7%)
State: 3.3 acres (Less than 1%)
Total: 1,036.5 acres


