## **PROPOSED CHANGE**

THE APPLICANT PROPOSES TO CHANGE THE POINT OF DIVERSION AND PLACE OF USE FOR STATEMENTS OF CLAIM 41F 132837-00, 41F 132838-00, 41F 136475-00, 41F 136476-00, 41F 136477-00, AND 41F 136478-00. THE APPLICANT ALSO PROPOSES TO TEMPORARILY CHANGE THE PURPOSE, PLACE OF USE, AND POINT OF DIVERSION TO INSTREAM FISHERY PURPOSE FOR A PORTION OF THE ABOVE REFERENCED WATER RIGHTS. THE SOURCE IS THE MADISON RIVER AND THE PROJECT IS LOCATED IN GALLATIN COUNTY.

In general, the department will make a preliminary determination to grant or deny this application within 120 days of the date the application is deemed correct and complete. That date is currently unknown. If the preliminary determination is to grant the application, the application will be published in the local newspaper and a notice will be sent to appropriators who, according to the department records may be affected by the proposed appropriation. Individuals will have at least 15 days and no more than 60 days (specific deadline will be identified at time of notice) to submit an objection under § 85-2-308, MCA, after the application has been published in the newspaper.
