PAST USE OF WATER INCLUDED IRRIGATION ON 77 ACRES GENERALLY LOCATED WITHIN SECTION 32 OF T1N, R7E, GALLATIN COUNTY. DIVERSION OF WATER OCCURRED AS EARLY AS MAY 1 AND CONTINUED AS LATE AS OCTOBER 15. WATER WAS DIVERTED FROM OLSON CREEK INTO THE LOWE DITCHES FROM FOUR POINTS OF DIVERSION GENERALLY LOCATED IN SECTION 32, T1S, R7E, AT A FLOW RATE UP TO 2.92 CFS. THE CHANGED PLACE OF USE INCLUDES THE LOWER 0.7 MILES OF OLSON CREEK FROM THE UPSTREAM POINT OF DIVERSION IN THE NWSENE OF SECTION 32, T1N, R7E, GALLATIN COUNTY, TO THE CONFLUENCE WITH BRIDGER CREEK, AND CONTINUES DOWNSTREAM APPROXIMATELY 3 MILES TO THE CONFLUENCE OF STONE AND BRIDGER CREEKS NEAR THE OWNER'S DOWNSTREAM PROPERTY BOUNDARY IN THE NWNENE OF SECTION 17, T1S, R7E, GALLATIN COUNTY.
