### PAST USE OF WATER

PAST USE OF WATER INCLUDED IRRIGATION ON 99 ACRES GENERALLY LOCATED WITHIN SECTIONS 8 AND 9 OF T1S, R7E, GALLATIN COUNTY. DIVERSION OF WATER OCCURRED AS EARLY AS APRIL 1 AND CONTINUED AS LATE AS OCTOBER 31. WATER WAS DIVERTED FROM STONE CREEK INTO THE CARTER DITCH FROM TWO POINTS OF DIVERSION IN THE SE AND SW OF SECTION 9, T1S, R7E, AT A FLOW RATE UP TO 12.50 CFS. THE HISTORIC VOLUME CONSUMED BY PASTURE GRASS WAS 111.69 ACRE-FEET, AND A DIVERTED VOLUME OF 2693.99 ACRE-FEET WAS NECESSARY DUE TO DITCH LEAKAGE.

THE CHANGED PLACE OF USE INCLUDES THE LOWER 1.0 MILE OF STONE CREEK FROM THE POD IN THE SESESW OF SECTION 9, T1S, R7E, GALLATIN COUNTY, TO THE CONFLUENCE WITH BRIDGER CREEK NEAR THE OWNER'S DOWNSTREAM PROPERTY BOUNDARY IN THE NWNENE OF SECTION 17, T1S, R7E, GALLATIN COUNTY.THE RENEWAL PERIOD REQUESTED IS AN ADDITIONAL 10 YEARS.
