PAST USE OF WATER

PAST USE OF WATER INCLUDED IRRIGATION ON 88 ACRES GENERALLY LOCATED WITHIN SECTION 8 OF T1S, R7E, GALLATIN COUNTY. DIVERSION OF WATER OCCURRED AS EARLY AS APRIL 1 AND CONTINUED AS LATE AS OCTOBER 31. WATER WAS DIVERTED FROM PINE CREEK INTO THE OLSEN DITCH FROM A POINT OF DIVERSION IN THE NWSWNW OF SECTION 8, T1S, R7E, AT A FLOW RATE UP TO 5.00 CFS. THE HISTORIC VOLUME CONSUMED BY PASTURE GRASS WAS 99.28 ACRE-FEET, AND A DIVERTED VOLUME OF 1043.65 ACRE-FEET WAS NECESSARY DUE TO DITCH LEAKAGE.

PROPOSED CHANGE

THIS APPLICATION IS TO RENEW A TEMPORARY CHANGE. THE TEMPORARY CHANGE WAS ORIGINALLY ISSUED ON 08/01/2013 FOR A PERIOD OF TEN YEARS AND AUTHORIZED THE CHANGE OF WATER RIGHTS 41H 136666-00. A CHANGE IN PLACE OF USE AND PURPOSE OF USE OF A PORTION OF THE ABOVE RIGHT WAS AUTHORIZED FOR MAINTAINING AND ENHANCING STREAMFLOWS FOR FISHERIES FROM APRIL 1 THROUGH OCTOBER 31. THE CHANGED PLACE OF USE INCLUDES THE LOWER 0.85 MILES OF PINE CREEK FROM THE UPSTREAM POINT OF DIVERSION IN THE NWSWNW OF SECTION 8, T1S, R7E, GALLATIN COUNTY, TO THE CONFLUENCE WITH BRIDGER CREEK, AND CONTINUES DOWNSTREAM APPROXIMATELY 250 FEET TO THE CONFLUENCE OF STONE AND BRIDGER CREEKS NEAR THE OWNER'S DOWNSTREAM PROPERTY BOUNDARY IN THE NWNENE OF SECTION 17, T1S, R7E, GALLATIN COUNTY. THE RENEWAL PERIOD REQUESTED IS AN ADDITIONAL 10 YEARS.

ADDITIONAL INFORMATION

THIS APPLICATION WAS FILED SIMULTANEOUSLY WITH FOUR OTHER INSTREAM CHANGE APPLICATIONS FOR OLSON, WHITE, STONE, AND BRIDGER CREEKS AS PART OF THE SAME TROUT UNLIMITED PROJECT.
