PAST USE OF WATER

HISTORICALLY WATER WAS DIVERTED AT 9.48 CUBIC FEET PER SECOND (CFS) FROM APRIL 15 TO MAY 14, AND 34.33 CFS FROM MAY 15 TO OCTOBER 15, FOR THE PURPOSE OF FLOOD IRRIGATION WITH THE MOST SENIOR PRIORITY DATE OF JUNE 1, 1884. THE PLACES OF USE ARE CONTAINED WITHIN 350 ACRES GENERALLY LOCATED IN SECTIONS 2,3,4, AND 5; ALL LOCATED IN T01N, R08E, PARK COUNTY, AND SECTIONS 33 AND 34, T02N, R08E, PARK COUNTY. APPLICANT IS CHANGING ALL WATER RIGHTS ASSOCIATED TO THE HISTORIC PLACE OF USE; THE HISTORIC PLACE OF USE WILL NOT BE IRRIGATED BY ANY OTHER WATER RIGHT. THE SEVEN POINTS OF DIVERSION (POD) ARE GENERALLY LOCATED IN: NWNWNW OF SECTION 3, NENENW OF SECTION 3, NENWNE OF SECTION 4, NENENE OF SECTION 5, AND NENWNE OF SECTION 5, T01N, R08E, PARK COUNTY; AND NESESW OF SECTION 31, T02N, R08E, PARK COUNTY. THE ENTIRE PLACE OF USE IS LOCATED 6 MILES WEST OF CLYDE PARK, MT.

PROPOSED CHANGE

THIS APPLICATION IS TO RENEW A TEMPORARY CHANGE. THE TEMPORARY CHANGE WAS ORIGINALLY ISSUED ON 01/23/2013 FOR A PERIOD OF TEN YEARS AND AUTHORIZED THE CHANGE OF A PORTION OF WATER RIGHTS 43A 33116-00, 43A 33117-00, 43A 33119-00, 43A 33121-00, 43A 33122-00, 43A 33123-00, 43A 33123-01, 43A 33124-00, 43A 33125-00, 43A 33125-01, 43A 33126-00, 43A 33126-01, 43A 33128-00, and 43A 33128-01. A CHANGE IN PLACE OF USE AND PURPOSE OF USE OF A PORTION OF THE ABOVE RIGHTS WAS AUTHORIZED OCTOBER 15. THE CHANGED PLACE OF USE INCLUDES BRACKETT CREEK FROM THE MOST UPSTREAM POINT OF DIVERSION, ALSO CALLED POD #1 OR THE BIG DITCH, IN THE NESESW OF SECTION 31, T02N, R08E, PARK COUNTY, TO A POINT FOUR MILES DOWNSTREAM IN THE NENWNE OF SECTION 02, T01N, R08E, PARK COUNTY, WITH ALL PROPERTY ADJACENT TO THE CREEK IN THE PROTECTED REACH BEING OWNED BY THE APPLICANT. THE RENEWAL PERIOD REQUESTED IS AN ADDITIONAL 10 YEARS.
