2. **Type of action:** Change Application 76H 30171414
3. **Water source name:** Groundwater
4. **Location affected by project:** Section 2, Township 12 North, Range 20 West, Missoula County. Bitterroot River from the southern boundary of the SESW Section 2, T12N, R20W to the confluence of the Bitterroot and Clark Fork Rivers in the NWNW Sec. 27, T13N, R20W.
5. **Narrative summary of the proposed project, purpose, action to be taken, and benefits:** Peak Health Management Company LLC proposes to reduce diversion of water from two wells in the NWSE Sec. 2 T12N, R20W and to cease irrigation on 0.46 acres of lawn and garden. The reduction in water use will result in the elimination of 0.78 AF of historical depletions to the Bitterroot River. This water, made newly available in the Bitterroot, will be used to mitigate depletions arising from proposed Permit Application 76H 30150412.  
The DNRC shall issue a change authorization if an applicant proves the criteria in 85-2-402 MCA are met.

## **Part II. Environmental Review**

### **Environmental Impact Checklist:**

#### **PHYSICAL ENVIRONMENT**

##### **WATER QUANTITY, QUALITY AND DISTRIBUTION**

**Water quantity** - *Assess whether the source of supply is identified as a chronically or periodically dewatered stream by DFWP. Assess whether the proposed use will worsen the already dewatered condition.*

This reach of the Bitterroot River is not identified as a chronically or periodically dewatered stream by DFWP. This application is for aquifer recharge to offset depletions to the Bitterroot River by another application. The total consumptive use of water under this Statement of Claim will decrease if this change application is approved.

*Determination:* No significant impact

**Water quality** - *Assess whether the stream is listed as water quality impaired or threatened by DEQ, and whether the proposed project will affect water quality.*

The Bitterroot River is not considered to have impaired water quality by DEQ. The proposed application for aquifer recharge is not expected to negatively affect water quality.

*Determination:* No significant impact

**Groundwater** - *Assess if the proposed project impacts ground water quality or supply. If this is a groundwater appropriation, assess if it could impact adjacent surface water flows.*

This application is for a reduction in groundwater appropriation, which will result in 0.78AF of water historically depleted from the Bitterroot River being left undiverted. No negative effects on groundwater quality or supply are anticipated as a result of this change.

*Determination:* No significant impact

**DIVERSION WORKS** - *Assess whether the means of diversion, construction and operation of the appropriation works of the proposed project will impact any of the following: channel impacts, flow modifications, barriers, riparian areas, dams, well construction.*

The diversion works already exist. No new construction will occur.

*Determination:* No significant impacts.

## UNIQUE, ENDANGERED, FRAGILE OR LIMITED ENVIRONMENTAL RESOURCES

**Endangered and threatened species** - Assess whether the proposed project will impact any threatened or endangered fish, wildlife, plants or aquatic species or any “species of special concern,” or create a barrier to the migration or movement of fish or wildlife. For groundwater, assess whether the proposed project, including impacts on adjacent surface flows, would impact any threatened or endangered species or “species of special concern.”

The Montana Natural Heritage Program website was reviewed to determine if there are any “threatened” or “endangered” fish, wildlife, plants, or aquatic species that could potentially be impacted by this project. “Species of special concern” were also included in this search.

According to the Montana Natural Heritage Program, observations from the past 50 years indicate that 13 animal species of concern may be found in the area of potential impact. Of these, 2 species are listed as threatened by the USFWS in this area: the Grizzly Bear (*Ursus arctos*) and the Bull Trout (*Salvelinus confluentus*).

Monarch (*Danaus plexippus*)  
Northern Hoary Bat (*Lasiurus cinereus*)  
Cassin’s Finch (*Haemorhous cassinii*)  
Clark’s Nutcracker (*Nucifraga columbiana*)  
Evening Grosbeak (*Coccothraustes vespertinus*)  
Great Blue Heron (*Ardea herodias*)  
Pileated Woodpecker (*Dryocopus pileatus*)  
Bull Trout (*Salvelinus confluentus*)  
Westslope Cutthroat Trout (*Oncorhynchus lewisi*)

The reduction of irrigation proposed in this project is not anticipated to adversely affect any of these species.

*Determination:* No significant impact.

**Wetlands** - Consult and assess whether the apparent wetland is a functional wetland (according to COE definitions), and whether the wetland resource would be impacted.

The area in which the diversion and conveyance structures will be constructed contain riparian emergent and freshwater emergent wetland. The diversion and conveyance structures are not anticipated to disrupt these ecosystems. The proposed aquifer recharge plan may raise groundwater levels in the area.

*Determination:* No significant impact.

**Ponds** - For ponds, consult and assess whether existing wildlife, waterfowl, or fisheries resources would be impacted.

*Determination:* N/A – This project does not involve ponds.

**GEOLOGY/SOIL QUALITY, STABILITY AND MOISTURE** - Assess whether there will be degradation of soil quality, alteration of soil stability, or moisture content. Assess whether the soils are heavy in salts that could cause saline seep.

No new construction or development is proposed to occur. This change is to reduce permitted irrigation on land which has already been developed into new buildings and parking lots. No change to the soils is expected.

*Determination:* No significant impact

**VEGETATION COVER, QUANTITY AND QUALITY/NOXIOUS WEEDS** - Assess impacts to existing vegetative cover. Assess whether the proposed project would result in the establishment or spread of noxious weeds.

No new construction or development is proposed to occur. The areas no longer irrigated have already been replaced with new impermeable surfaces (parking lot, buildings). No spread of noxious weeds will occur.

*Determination:* No significant impact

**AIR QUALITY** - Assess whether there will be a deterioration of air quality or adverse effects on vegetation due to increased air pollutants.

No negative effects to air quality are expected as a result of this proposal.

*Determination:* No significant impact
