THE APPLICANT STATES THAT WATER IS NO LONGER RELIABLY AVAILABLE AT THE HISTORICAL POINT OF DIVERSION AND PROPOSES TO ADD A SECOND POINT OF DIVERSION AT A LOCATION WHERE WATER IS AVAILABLE. THE HISTORICAL POINT OF DIVERSION WILL BE RETAINED AND USED TO IRRIGATE SOME OF THE HISTORICALLY IRRIGATED ACREAGE WHEN WATER IS AVAILABLE AT THAT PUMP SITE.
