- 3.4. Water Conservation Specialist Advertising Proposal (CSKT-Melissa-Schlichting)
  - M. Schlichting: The HR firm provided this proposal to advertise the position in LinkedIn, Job Jupiter, and indeed. The HR firm would also post the position on certain free job boards. Paid promotion would cost between \$700 and \$1300 depending on how much the position is promoted on each of the sites. This is an upper and lower limit.
  - C. Matt: Are there any comments or questions from the board? Would the position be advertised locally?
  - M. Schlichting: We could suggest local places. Are there any particular local places you would like it advertised? This position requires a different level of education and experience than the Admin/CT position, so we want to promote it more broadly. It costs about \$700 to advertise the previous position in the local newspaper.
  - T. Wall-McDonald: I provided some places to post the Water Engineer position to Melissa. One that I use is the Polson Job Service, and they post at three additional job boards at not cost. I think this is a pretty reasonable cost with a sufficient distribution. If we established a \$1500 cap to get the widest distribution we could, I am comfortable with that. We can put it on SKT bulletin board as well.
  - R. Noble: I suggest putting it on the DNRC and CSKT site. I also suggest another site I will provide to you. I agree with Teresa.
  - M. Schlichting: I will make sure it also goes to SKC, CSKT, and DNRC.
