NOTICE OF ENTRY OF PRELIMINARY DECREE AND NOTICE OF AVAILABILITY

THIS IS AN IMPORTANT NOTICE REGARDING YOUR WATER RIGHTS

The Montana Water Court issued a Decree (a list of water rights) in your Basin. This notice may include an abstract (a description of your water right as decreed).

- If an abstract is included with this notice, then your water right is part of the Decree.
- If an abstract is not included with this notice, then your water right is not part of the current Decree.

WHAT IS THE PRELIMINARY DECREE?

The Decree includes abstracts of existing water rights on all sources of water within Basin 76G. These water rights were reexamined by the Montana Department of Natural Resources and Conservation (DNRC) pursuant to Water Court orders. The DNRC may have made changes or identified potential problems on your abstract by placing "issue remarks" on the abstract.

If you believe any water rights in the Decree do not reflect historical (before July 1, 1973) beneficial use, you must file an objection by **May 13, 2025**. Objections must be filed on the forms provided by the Water Court. The forms can be found at: <https://courts.mt.gov/Courts/Water/LegalResources> or by contacting the Court: watercourt@mt.gov or (406) 586-4364.

Any request to extend the objection deadline must be filed by May 13, 2025. If an extension is granted it will be advertised in the *Associate Silver State Post*, *The Missoulian*, *Montana Standard*, and *Anaconda Leader*.

WHAT'S NEXT?

The Water Court will be offering informal public meetings to explain the objection process on the following dates:

- **Wednesday, January 15, 2025, at 6:00 pm in person** at the Butte Archives Auditorium, 17 W. Quartz St, Butte, MT 59701
- **Wednesday, January 22, 2025, at 12:00 pm via Zoom**. To take part in the telephone conference, dial (646) 558-8656, enter the Meeting ID 823 5516 2974 #, then press # to skip participant ID, then enter the meeting password 345215 #

If someone objects to your water rights, the Court will notify you, and you may file a counterobjection to your objector's water rights in this decree. After all notice periods pass, the Water Court will address all objections, counterobjections, and issue remarks. **Make sure your address is up to date with the DNRC.** You can contact the DNRC at the address below:
